Ways to Vote

1. EARLY/ADVANCE VOTING (ANNEX OFFICE ONLY)

From JUNE 10th to JUNE 14th, there will be a period of *in-person, no-excuse voting* at the **BULLOCH COUNTY ANNEX-ELECTION'S OFFICE**-prior to Election Day. This will carry on daily (**M-F**) from 8:00 AM to 5:00 PM.

2. MAIL-OUT ABSENTEE BALLOT

Voters can complete an Application for an Absentee Ballot. Once we receive it, we can mail your ballot to the address requested, *outside of Bulloch County* or to the address where you are currently registered to vote *within the county* (or alternate address for physically disabled voter). The **deadline** to request an Absentee Ballot is **JUNE 7th**.

3. ELECTION DAY

This will occur at your voting precinct on **JUNE 18th** from 7:00 AM to 7:00 PM.

BRING YOUR PHOTO I.D.

- A GEORGIA DRIVER'S LICENSE; or
- Valid identification card "picture" issued by a branch, department, agency or entity of the State of Georgia, another state; or
- Valid United States passport; or
- Valid employee identification card containing a photograph of and issued by any branch, department, agency or entity of the United States government, this state, or any county, municipality board, authority, or
- Other entity of this state; or valid US military identification card with photograph; or
- Valid tribal identification card with photograph

Who CAN vote in the Runoff?

- Voters who voted a **Republican Ballot** and are registered in **County Commissioner District 2**
- Voters who voted a **Nonpartisan Ballot** and are registered in **County Commissioner District 2**
- Voters who **did not** vote in the **May 21st General Primary and Nonpartisan Election** and are registered in **County Commissioner District 2**

Who CANNOT vote in the Runoff?

- Voters who voted a **Democratic Ballot** in the **May 21st General Primary and Nonpartisan Election**
- Voters who are registered in **County Commissioner District 1**
